Participant Agreement

Welcome! Thank you for joining the Junior Achievement £50 Challenge. This is a fun, creative fundraising initiative to help raise funds for our charity.

To make sure everyone has a safe, fair, and enjoyable experience, please read and agree to the following guidelines.

Eligibility

- Open to individuals, community groups, schools and workplace teams.
- Participants under 18 must have a responsible adult supervising all activities.

Starter Funds

- Each participant/team will receive £50
- Starter funds must only be used for challenge-related fundraising. Personal use is not allowed.

Permitted Activities

Participants may use the starter funds for safe, legal fundraising activities, including:

- Sales of goods or services
- Creative events
- Community activities

Activities NOT permitted:

- Gambling, lotteries, or unlicensed prize draws
- Unsafe or illegal activities
- Activities that could harm Junior Achievement's reputation

Food sales:

- All food sold must comply with relevant health and safety regulations.

Conduct

Participants agree to:

- Act responsibly and respectfully
- Avoid any activity that could damage Junior Achievement's reputation
- Obtain permissions for any locations, equipment, or third-party involvement
